ANNOUNCEMENT POWER GENERATION FOR JUNE 2024

The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for June 2024 on a consolidated basis amounted to 5,692,398 MWh, representing a year-on-year increase of 3.05% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 2.10%, the coal-fired power generation registered a decrease of 11.79%, and other renewable energy power generation of the Group for 2024 amounted to 40,081,845 MWh, representing a year-on-year increase of 0.84% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 4.60%, the coal-fired power generation registered a decrease of 2.39%, and other renewable energy power generation registered an increase of 122.87%.
